3) For ODC Container, H&T charges will be 2 times of normal Charges

4) On above handling charges an amount of Rs. 900/- per TEU as fuel surcharges shall be applicable as extra.

5) Insurance Charges is for Custom Duty only, Not for Stored Cargo. If importer require Cargo insurance than it's up to Importer Only. Insurance Charges will be applicable 0.19 % on duty amount (Monthly)
